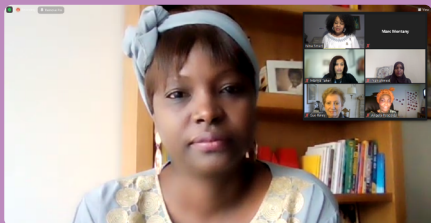

THIS YEAR, WE CONTINUED TO ADVOCATE TO PREVENT AND RESPOND TO FGM



With European Week of Action for Girls partners, we organised **5 live events** involving over **30 youth advocates** and **10 EU-AU decisionmakers**.

We contributed to **6 EU policy processes**, including the Violence Against Women & Domestic Violence Directive proposal, the Youth Action plan and the revision of the Victims Rights Directive.

We had over **20 advocacy meetings in 2021** (including with DG JUST, DG ECHO, UN Women and the Victims' Rights Platform).

We gathered **33 organizations from 21 countries** across Africa, Europe and North America at our international stakeholder dialogue (ISD) on “Gender transformative approaches to End FGM” with our Members AIDOS and GAMS Belgium.

We co-organised a **successful advocacy campaign** around EU funding for social issues (including anti-FGM work).

We addressed **3 letters to the Presidencies of the Council of the EU** (Portugal, Slovenia, France).



We participated in over **12 international and European events** as speakers.

We produced **2 GREVIO Shadow Reports** on the implementation of the Istanbul Convention in Switzerland and Cyprus.

THIS YEAR WE ALSO WORKED ON 5 AMAZING PROJECTS ACROSS EUROPE



We shared knowledge and provided **trainings** to youth activists on online safe-spaces through the **IPPF - YSAFE Project** on “Joining the EU discussion on FGM and Sexual education in 2022”.

We created space for **community grassroots activists** through the “**Understanding community voices**” project.

The **8 portraits** of these inspiring anti-FGM advocates were viewed over **1000 times**.

Through the CHAIN project, in partnership with **ActionAid Italia**, **Equipop** (France), **TERRE DES FEMMES** (Germany), **Save a Girl**, **Save a Generation** (Spain), we created and launched an EU-wide **awareness raising campaign** on Early and Forced Marriage and FGM targeted towards communities, which reached over **50 000 people**. **C H A I N**

We launched the **Mind the Gap Brochure** for educators, co-created with our partners and Members **Aidos** (Italy), **APF Portugal** and **Medicos del Mundo** (Spain).

The brochure was seen online over **500 times**.



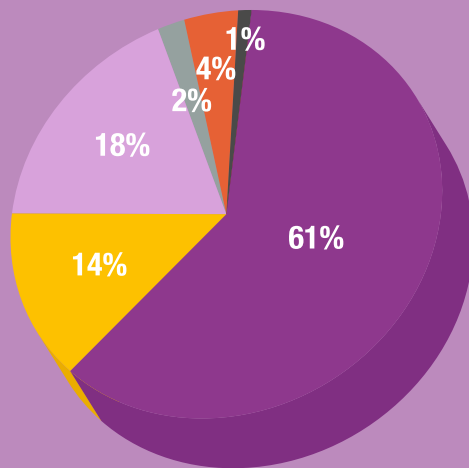

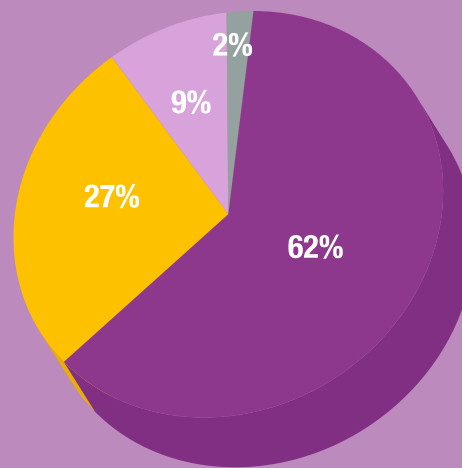

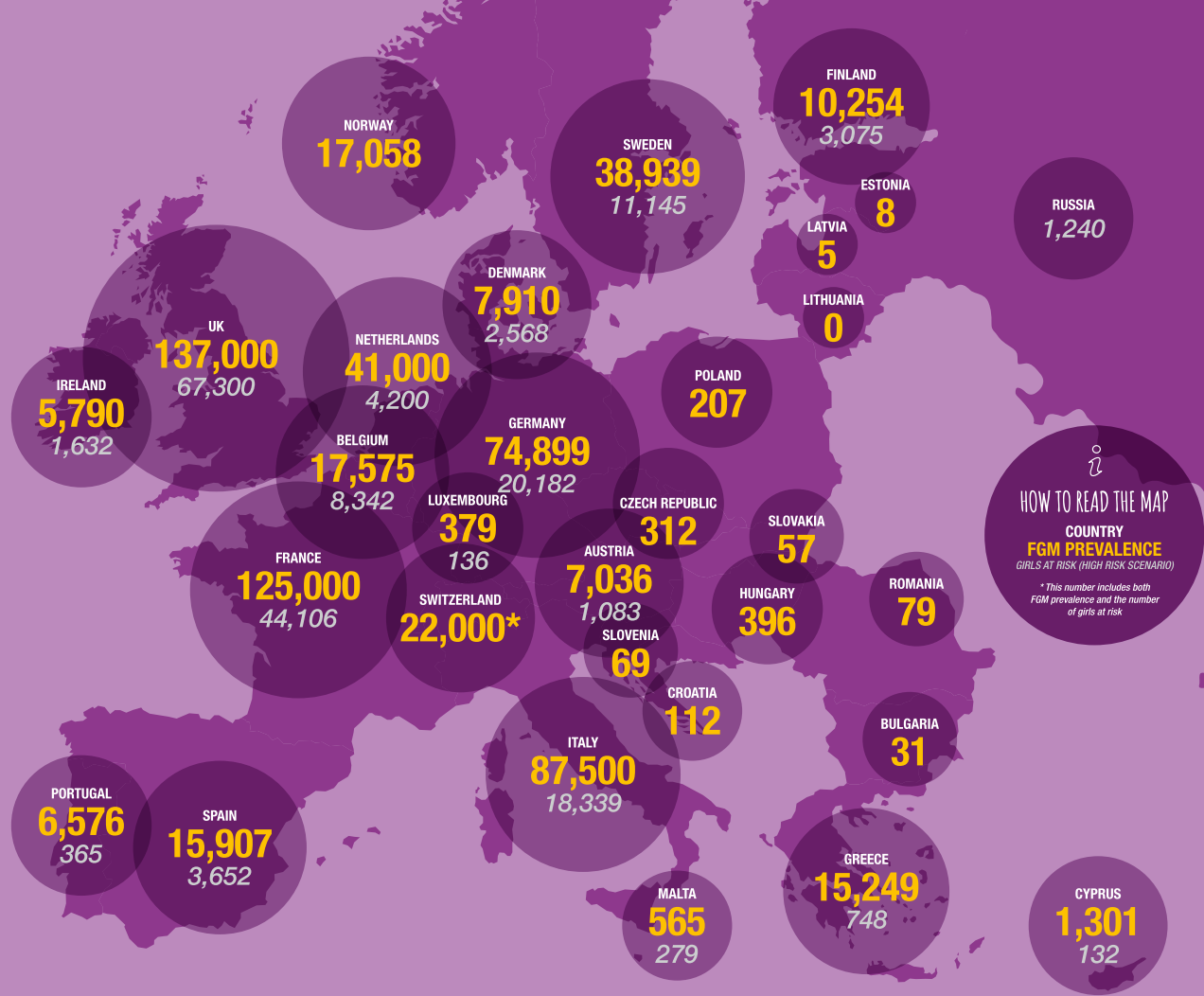


FGM IN EUROPE: PREVALENCE AND GIRLS AT RISK

At least **200 million** women and girls alive today have undergone FGM and **4.1 million** have been subjected to FGM only in 2020.

It is estimated that there are over **600.000 FGM survivors** living in Europe and around **190.000 are at risk** in **17 countries** alone.

This data has been internally gathered by the End FGM European Network using existing studies. It should be noted that methodologies used for the studies differ as well as the years of data collection. In the meantime, some countries have noted significant increases in the numbers. The collection of data continues to be a huge challenge.
